

Community Impact Awards Highlight Philanthropic Excellence in Johnson County

The Community Foundation Board of Directors and staff announced the recognition of four Community Impact Awards at the 2023 Community Celebration. These noncompetitive awards recognize individuals, businesses, families, and organizations making positive impacts in our community through their philanthropic work. The following awardees were recognized:

- Community Collaborator Rotary-Kerber Heartsafe Fund
- Corporate Community Partner United Iowa Financial
- Community Convener: Equity & Inclusion City of Iowa City, Office of Equity and Human Rights
- Community Catalyst Dr. Pete Wallace

Each of these awards highlight important philanthropic work in our community.

The Community Collaborator Award recognized the Rotary-Kerber Heartsafe Fund. which provides CPR training and discounted AEDs to area businesses and nonprofits. Additionally, they work with the Johnson County Ambulance Service to spread awareness and use of the mobile app, PulsePoint, which allows residents to respond quickly to provide potentially life-saving aid to persons experiencing sudden cardiac arrest in public spaces.

The Corporate Community Partner Award recognized United Iowa Financial for their financial support of local education through the Support Our Schools Fund, founded by United Iowa Financial, which addresses student needs that create obstacles to attendance, self-esteem, and academic success. United Iowa Financial also stepped up during the coronavirus pandemic to make a \$10,000 grant to fund a utility trailer for the Johnson County Emergency Response Team. United Iowa Financial Partner, Eli Wynes stated, "At United Iowa Financial, one of our core principles is 'Community.' We encourage our staff to volunteer, serve on boards of directors for local organizations, and we give back together through volunteering and making grants as a team. We were honored to receive this recognition for our commitment to community."

The Community Convener Award recognized the City of Iowa City Office of Equity and Human Rights for their exceptional work in educating our community on diversity, equity, and access best practices. They share monthly e-newsletters, host frequent trainings and professional development opportunities, and administer Racial Equity and Social Justice Grants to organizations doing good work in our communities.

Finally, the Community Catalyst Award highlighted the work of Dr. Pete Wallace, a longtime friend of the Community Foundation and partner to many, for his work with the lowa City Healthy Kids School-Based Clinics. Dr. Wallace supports the Healthy Kids Clinics by spreading awareness and advocacy for the good work the clinics do to support children's healthcare in our community. Dr. Wallace is also an avid philanthropist and fundraiser for the Clinics, assisting in their annual fundraising campaigns and garnering financial support to help sustain the clinics. Dr. Wallace is a retired healthcare provider and has dedicated his life to improving access to healthcare for all.

CFJC Has Record-Breaking Year, Granting Over \$3 Million

This year, the Community Foundation made history with a record-breaking \$3,269,169 in grants awarded to nonprofit organizations. These grants are a combination of contributions recommended by our donors from their funds held at the Community Foundation, grants made during our competitive grant cycle, and awards directed by the CFJC Board of Directors for specific community initiatives. Throughout the year, donors work one-on-one with CFJC staff to recommend grants to organizations and causes that matter most to them. This personalized process is made even more simple with the use of our new Grants Catalog - an online resource for donors to view nonprofit needs and make grants directly to those requests. During the competitive grant cycle this year we were proud to award 62 grants totaling \$365,217 to local nonprofit organizations. These grants were made in partnership with 27 partner funders. including 26 donor advised funds and the 5224GOOD Giving Circle. Additionally, our Board of Directors made grants to community initiatives which support residents countywide. The CFJC is proud to be growing in our impact and look forward to continuing to support philanthropy in Johnson County.

Community Foundation of Johnson Count

72 Organizations Participate in the Second **Annual Johnson County Great Give Day**

One annual event that particularly highlights partnership in our community is Johnson County Great Give Day. Johnson County Great Give Day is a collective day of giving where donors are encouraged to learn more about new-tothem nonprofit organizations, the work of the nonprofit sector in Johnson County, and make a gift to support philanthropy in Johnson County. In its second year, Johnson County Great Give Day raised \$83,787 for our nonprofit community. Over 70 organizations participated in the day, sharing their own missions and the larger impact of the sector in our community. Johnson County Great Give Day is powered by the Community Foundation of Johnson County but is a celebration of the work of nonprofits and donors across the county.

Coralville Community Fund Supports Nine Projects through Local Grantmaking

The Coralville Community Fund, led by a committee of local community leaders, awarded \$23,500 in grants to nine local nonprofit organizations during their 2024 Coralville Community Fund Grant Cycle. The committee oversees the recommendation of grants from the Coralville Community Fund, an endowed fund held at the Community Foundation of Johnson County. The fund supports nonprofit organizations and charitable projects which benefit the residents of Coralville. This year's grant award recipients were:

Brewing Up a Special Partnership

The Community Foundation of Johnson County is proud to hold the North Liberty Centennial Park Next Stage Campaign's Charitable Giving Fund. This fund was created to receive charitable donations of any amount to support the capital campaign for North Liberty's Next Stage Centennial Park Project. Donations to the fund support the park's renovations and future community events held in Centennial Park. In January 2024, a new partnership with Field Day Brewing allowed community members to contribute to the project in a new way — through (responsible) beer consumption! The City of North Liberty and Community Foundation of Johnson County partnered with Field Day Brewing to release a special "Centennial Park Pilsner." For every pint in the taproom or 4-pack purchased to-go, Field Day will donate \$1 to Building North Liberty's Next Stage Campaign, with the goal of reaching \$50,000. Centennial Park Pilsner is a contemporary American pilsner dry-hopped with Centennial hops. "We wanted to brew something special for the park," said Alec Travis with Field Day Brewing, "so we brewed this beer to have lemon, melon, and floral notes. It's crushable year-round, and especially on hot summer days when you want the beer to go down easy." The pilsner is available at Field Day Brewing and is expected to be available at local events and other establishments throughout 2024. Patrons can see progress toward the \$50,000 goal on an oversized tracker installed in the brewery. "When we heard about the Centennial Park project, we knew there was a space for us to be helpful as the home for the campaign fund," said Community Foundation of Johnson County President and CEO Shelly Maharry. "We love creativity and Field Day has created such a fun avenue for people to give back through this partnership with the City of North Liberty."

Community Conversation Lifts Up the Work of Nine Partner Organizations Addressing Affordable Housing In Johnson County

In June 2024, the Community Foundation of Johnson County hosted a Community Conversation on Affordable Housing. This free community event offered community members a glimpse into the work of nine partner organizations who focus their efforts on affordable housing in our community. The event started with a presentation from Ellen McCabe of the Housing Trust Fund of Johnson County who gave an overview of the current state of housing in our county. After Ellen set the stage with her presentation, a panel of local experts from The Housing Fellowship, Shelter House, Iowa Valley Habitat for Humanity, Houses Into Homes, Iowa City Catholic Worker, the Iowa City Community School District, and Open Heartland discussed their current work, successes, and challenges, which was moderated by Jessica Andino of the Johnson County Affordable Housing Coalition. The evening ended with Q&A from the audience, kick-starting an engaging conversation on housing in our community. "The Community Conversation was a way for our organizations to uplift the important issue of affordable housing and share our work with the community. We were thrilled the Community Foundation chose affordable housing as the first Community Conversation topic, as we feel it is an important issue our community is facing," said Jessica Andino with the Johnson County Affordable Housing Coalition. "We are proud of the partnerships between the organizations represented at the event and many more who are working together to address the complex issue of affordable housing in our community." This learning session was the first in a new series of Community Conversations hosted by the Community Foundation to convene our community on a variety of important topics.

Partnership for Placemaking

Building North Liberty's Next Stage, the Centennial Park development project, is a community-wide initiative that, when complete, will draw inspiring arts and cultural events, big-name artists, and tourists to the Corridor. It will also provide a new venue for nonprofit events, family gatherings, and community events which will boost placemaking in North Liberty and the Corridor. The Community Foundation has been part of the campaign from the beginning, holding the fund for community gifts to support the project. This year, the Board of Directors of the CFJC made an additional investment in the community by giving a \$50,000 grant to the Centennial Park Project. This grant was not only substantial on its own, but was able to be leveraged to help obtain over \$1 million in additional gifts from other local funders.

CFJC Partnership Helps Big Brothers Big Sisters of Johnson County Continue to Serve Families

In October 2023, the Johnson County Extension Council unexpectedly voted to disaffiliate with Big Brothers Big Sisters of Johnson County (BBBS) after 47 years of partnership. The organization faced significant financial and logistical challenges as they worked to transition into an independent, 501(c)3 nonprofit organization. Big Brothers Big Sisters of Johnson County is part of a national program created in 1904 to provide youth mentoring services through matching adult volunteers with children and creating opportunities for professionally supported one-on-one mentoring services. The program has been serving the Johnson County area for 47 years and currently serves over 300 families.

In an effort to support this long-standing local program which provides unique resources to these 300 families in our community, the Community Foundation of Johnson County provided a temporary fiscal sponsorship to allow BBBS to maintain continuity of their programming while BBBS worked to obtain their own 501(c)3 status. The Community Foundation stepped in and provided this service to Big Brothers Big Sisters of Johnson County to ensure their operations could continue until their full nonprofit status was resumed. The CFJC provided administration of charitable contributions, ensuring donors still had access to eligible tax-exemptions and secure donation processing.

"The partnership with the CFJC allowed us to continue to make an impact on the families we serve, maintaining consistency and stability for our clients during a time of such uncertainty for the organization. Because of our partnership with the CFJC, we had security and peace-of-mind for our staff, donors, volunteers, and clients until we were able to get our own 501(c)3 status and resume operations as normal," stated Daleta Thurness, Executive Director of Big Brothers Big Sisters of Johnson County.

The Community Foundation of Johnson County does not typically provide this type of service to organizations, but due to extreme circumstances in this case and its temporary nature, we were glad to be able to provide this support to the Big Brothers Big Sisters staff and board as well as the 300 local families they serve.

Supporting Nonprofit Staff through Free Professional Development

Each year, the Johnson County Nonprofit Alliance, powered by the Community Foundation of Johnson County, hosts free professional development for nonprofit professionals. These sessions draw on the expertise of local leaders to share their successes and challenges in a webinar format. This year the CFJC hosted sessions on a variety of topics including: accessibility of space and services; extending programming outside of your organization's walls; making your organization more energy efficient; and fundraising tools and tricks. The sessions are free and open to the public, and provide a space for professional development, networking, and partnership building. These free Education Sessions are one of many resources available to local nonprofits through the Johnson County Nonprofit Alliance. Peer groups, a book club, and online tools such as a community calendar, career center, and resource hub are available as well. The Community Foundation is proud to power the Johnson County Nonprofit Alliance to ensure our nonprofit sector continues to collaborate, partner, and thrive.



Partner with the CFJC to Support Local Nonprofit Needs

At the Community Celebration in November 2023, the Community Foundation announced the launch of a new community donor giving tool — the CFJC Giving Catalog. The CFJC Giving Catalog is a new donor giving tool on our website which facilitates crowdfunding for current local nonprofit needs. This resource is designed to assist donors in finding nonprofit requests that resonate with their charitable giving interests and goals. The tool allows nonprofit organizations to request funding for projects of up to \$10,000 and our community to work together to fund those requests. Gifts of any amount are beneficial, as these gifts pool together to make a larger impact for nonprofits in our community.
